STATEMENT OF UNDERSTANDING AND RELEASE AGREEMENT

THE UNDERSIGN IS AWARE AND ACKNOWLEDGES THAT THE PARTICIPATION IN THESE ACITIVITIES INVOLVES NUMEROUS RISKS OF INJURY, INCLUDING PARALYSIS AND DEATH, AND THE UNDERSIGN FREELY ASSUMES THOSE RISKS.

IN CONSIDERATION FOR ALLOWING USER TO USE FACILITIES OF CHAMINADE COLLEGE PREPARATORY, I AGREE TO RELEASE FROM ANY LEGAL LIABILITY AND AGREE NOT TO SUE CHAMINADE COLLEGE PREPARATORY, ITS DIRECTORS, ADMINISTRATORS, TEACHERS, EMPLOYEES AND AGENTS FOR ANY AND ALL INJURIES CAUSED BY OR RESULTING FROM ANY PARTICIPATION IN USER ACTIVITIES. THIS RELEASE EXTENDS TO CLAIM WHICH I COULD ASSERT OR WHICH COULD BE ASSERTED BY, OR ON BEHALF OF MY CHILD.
